OFFICIAL RULES

OPEN TO RESIDENTS OF THE 50 UNITED STATES AND D.C 18 YEARS OF AGE AND OLDER ONLY

Entries must be postmarked by November 6, 2020 and received by November 9, 2020. Limit one entry per envelope. An entrant may not enter with multiple identities.
